## American with Disabilities Act

Something that should never be forgotten is to take into consideration at all of our events the wide diversity of people in attendance. Specifically, those that are wheelchair bound. I encountered one such incident recently. I failed to provide wheelchair accessible porta johns. I apologized profusely to the individual, but at that point in time - during the event - my hands were tied.

But, then I got to thinking ... possibly the City Parks, Recreation and Cultural Services should have provided such equipment within their parks or that at least it should be part of the Special Events Application/ Permit. Below is the response that I received from Mr. Kurt Schroeder.

Pat, Thanks for keeping us updated on this. In reference to our "policy" on providing handicap porta-johns, we've learned the "hard way" just as you have. At special events that we are co-sponsors of (4th of July, Balloon Classic, etc.) as a mater of course we will order a mix of standard and accessible porta-johns. Any new restrooms we build will be accessible and we have been updating older restrooms (if possible -some we must just tear down and start over fresh) to be accessible -

we've just completed modifications to the Thorndale Park and Boulder Park restrooms. We have also been installing porta-john enclosures at new neighborhood parks and are installing three or four a year at existing parks. All of the enclosures can accommodate an accessible unit.

I think you handled Mr. \_\_\_\_\_ concerns quite well. His frustration is real and justified but it sounds like he is satisfied that he has been heard and will return to help again. I will make sure that Laura suggests to people that are using our parks for special events to include a number of accessible porta-johns in their mix. After early mistakes, knowing to do so is now second nature to us. Looks like we need to keep in mind that others will not have the same experience as us and therefore not know to do so.

Let me know if there is anything else I can help you with.
